Redemption is only available online through the **MY AEG website**.

PROMOTER

This redemption is being conducted by Techtronic Industries Australia Pty Ltd (ABN: 98 002 277 509) of 31 Gilby Road, Mount Waverley VIC 3149 (**Promoter**).

ELIGIBLE CLAIMANTS

The redemption is only open to eligible claimants. An “eligible claimant” is a person who:

- a) is either an Australian citizen or an Australian permanent resident;
- b) provides an Australian (physical) street address, that is not a PO Box address;
- c) complies with and submits a registration application for this redemption in accordance with these Terms and Conditions;
- d) registers this redemption for himself or herself exclusively and not on behalf of any other person or group of persons;
- e) does not in any way tamper with the redemption and/or the registration process for the redemption;
- f) enters the correct serial/model numbers for the relevant products and for all products in a product kit; and
- g) purchases the listed AEG product from Bunnings (Australia), Tool Kit Depot (Australia) or via AEG Onsite Trade Solutions (Australia) in Australia.

REDEMPTION & PROMOTION PERIOD

The redemption offer only applies to new products outlined in table 1 of the promotion list, purchased from Bunnings (Australia), Tool Kit Depot (Australia) or via AEG Onsite Trade Solutions (Australia) in Australia (Promotion List). - Once you register your product, there will be a pop-up notification to confirm whether you can redeem a bonus offer;
- Click the redeem button and proceed to fill out the form;** and
- Once submitted, you will receive an email notification of your application and upon verification and if you qualify as per these Terms and Conditions, your redemption bonus offer will be sent to you.

There is no fee charged to register for this redemption, once you have purchased a qualifying product (from the products listed in Table 1), other than the cost of you accessing the Internet.

DELIVERY

It may take between 8-12 weeks for delivery of the bonus offer.
